



LIABILITY RELEASE AND INDEMNIFICATION FORM FOR MINOR TRAVEL

I, the undersigned participant and parent, request voluntary participation for minor to travel to and from Rising Stars events for the dates from, December 3, 2023 through, December 31, 2024.
